Minutes of the XIV Meeting of the Steering Committee of CAPTAC-DR

June 27th, 2022

- 1. The discussion was centered around the following topics: (i) advances in the integration of surveillance and program work with capacity development (CD); main CD results for fiscal year 2022 (FY22) and proposed work program and budget for FY23; (iii) progress in the incorporation of digitalization in the Center's work program; and (iv) use of CD regional projects by the Center.
- 2. Committee members welcomed progress in the integration of surveillance and program work with CD. Members learned about a technical assistance (TA) coordination committee established for Guatemala, which involves participation from the Guatemalan authorities, the IMF, and CAPTAC-DR. The committee has helped improve inter and intra-institutional coordination of Fund and Center TA in the country, as well as identify difficulties with the implementation of TA recommendations and possible solutions to them. The committee fosters a global view of the Fund's work in the country and facilitates the integration of CD with surveillance work, which makes both TA and surveillance more effective and can help the authorities achieve their objectives.

Committee members also learned about the integration of CD and program work in Costa Rica. As part of Costa Rica's financial arrangement with the IMF, and with the support of CAPTAC-DR and the Fund's Fiscal Affairs Department (FAD), the Costa Rican tax administration developed a tax compliance improvement plan (TCIP), which strengthens institutional capacity to identify and manage tax risks and seeks to increase tax compliance. Implementation of the TCIP started in early 2022. Members also learned about the establishment of the Single System for the Payment of Social Resources (SUPRES, for its acronyms in Spanish) in the country. This was also part of Costa Rica's arrangement with the Fund and the establishment of the system was supported by CAPTAC-DR and FAD. In addition to promoting digitalization and financial inclusion, the system fosters good governance, accountability, and fiscal transparency, while strengthening the efficiency of public resource management. SUPRES started being implemented also in early 2022.

3. The Committee welcomed CD advances in FY22 and approved the Center's work program FY23. Members learned that CD delivered in FY22 was the highest in the last few years, reflecting the Center's response to increased needs derived from the pandemic and new IMF-supported programs in the region. They noted that the execution level of the FY22 workplan was 80 percent, broadly as in FY21. There was a slight decline in the overall milestone score relative to the previous year, which was, however, accompanied by a substantially higher number of milestones compared to FY21. Members supported the proposed workplan for FY23, which is the second largest of Phase III. They welcomed the gradual resumption of in-person CD work in FY23 and supported the envisaged mixed format (virtual and in-person) of CD delivery during the fiscal year.

- 4. The Committee approved the budget of US\$8.9 million for FY23. The budget is fully financed and is slightly higher than last year's, reflecting the expected resumption of travel and higher costs due to inflation. Committee members learned that the Center's financial resource shortfall relative to the overall budget for Phase III remained essentially unchanged from a year ago, at close to US\$7 million. Members pointed to the importance of fully financing the Center's activities across phases.
- 5. Members learned about the incorporation of digitalization in the work program, and the use of CD regional projects by the Center. Members welcomed progress achieved so far in integrating digitalization into different areas of the Center's work. They noted that the FY23 workplan further incorporates digitalization into the Center's CD activities. Members also learned about the Center's utilization of regional CD projects in tax and customs administration. It was noted that regional projects foster the efficiency of the Center's CD work, complement bilateral technical assistance, generate a network across country and institutions, and support the priorities of regional institutions. Regional projects also promote peer learning and the adoption of international best practices.

Member countries expressed their gratitude to financial partners for their support to CAPTAC-DR. The Steering Committee thanked CAPTAC-DR and the IMF for their continued support to CD in the region.
