Annex 5

Guidelines for the "Document Indicating Current Location" Requirement (Thai e-Visa)



1. Objective and Rationale

The "Document indicating current location" serves as official proof of the applicant's current residency or domicile.

The primary purpose of this requirement is to verify the applicant's physical location, ensuring that the e-Visa application is processed by the Royal Thai Embassy or Consulate-General with the correct geographical jurisdiction.

2. List of Acceptable Documents

Applicants must submit a clear copy of at least one of the following official documents to verify their current address:

- **Valid Visa or Residence Permit**: For applicants applying from a country other than their country of nationality, a valid visa or residence permit issued by the government of the current host country.
- **Flight Itinerary and Proof of Payment**: A confirmed flight itinerary accompanied by a payment receipt showing a departure flight originating from the applicant's current country of location.
- **Proof of Accommodation / Payment Receipt**: A recent payment receipt or confirmation of accommodation in the current location, or an official billing statement / receipt that clearly displays the applicant's name and current residential address.
- **Official Letter from Employer / Organization**: An official, government-issued identification card from the country of current residence.

3. Submission Requirements

- **Format**: Documents must be uploaded in standard digital formats (typically JPG or JPEG, as specified by the e-Visa portal).
- **Clarity and Consistency**: All uploaded files must be highly legible. The applicant's full name and residential address on the supporting document must exactly match the information declared in the e-Visa application form.

GUIDANCE ON YELLOW FEVER



- ◆ Participants traveling from or through [countries](#) designated as Yellow Fever Infected Areas must provide an International Health Certificate proving they have received a Yellow Fever vaccination.
- ◆ The international health certificate is a requirement for visa application and must also be presented to the immigration officer upon entry.
- ◆ For nationals of countries on the list who do not reside in or have not travelled from/through those countries, proof of domicile may be required.

Step 1

Create an Account

- **Access the Website:** Visit www.thaievisa.go.th and click the "Create an account" button at the top right corner.
- **Registration:** Select "**Individual**" account type and fill in your personal details (Name, Nationality, and Contact Number) in English.
- **Activation:** Check your email inbox for a verification link; you must click this link to activate your account before you can sign in.

Step 2

Fill in an Application Form

- **Check Eligibility:** After signing in, click "**Apply for a new visa**" and enter your passport country, current location, and the Embassy/Consulate where you wish to apply. (Please note that the eligible Thai Embassies/Consulates displayed are based on the applicant's current location.) **The selected office is for processing purposes only; your visa will be delivered electronically.**
- **Visa Selection:** Choose your Travel Document Type, Visa Type, and **Purpose of Visit (IMF/WBG Annual Meetings 2026).**
- **Personal & Travel Details:** Fill in all required fields marked with an asterisk (*).

Step 3

Upload Supporting Documents

- **Core Documents:** Upload a high-quality scan of your passport biodata page and a recent photograph taken within the last 6 months.
- **Specific Evidence:** Upload additional documents as required by your visa type (e.g., proof of current location or **AM2026 Registration Confirmation**).
- **Technical Limits:** Passport biodata page and photo must be in JPG or JPEG format only, while other supporting documents can be in JPG, JPEG or PDF format (File size limit: 3 MB)

Step 4

Pay Visa Fee

- **Proceed to Payment:** Access the "**Ready to submit**" tab menu, which lists completed applications pending payment. Select the complete application you want to submit, and click "**Proceed to Payment**".
- **Payment Methods:**
 - click "Pay Now" for online payment
 - click "Pay at the Embassy/Consulate General" to proceed with the submission of the application fee payment receipt.
 - click "**Payment Exempted**" for applications with fee exemption

Step 5

Wait for the Visa to be Processed

- **Tracking:** Use the "**Check Status**" or "**All Status**" tab to monitor your application's progress.
- **Information Requests:** If the status shows "**Request Document**" in red, click "View" to read the officer's remarks and upload the requested additional files.
- **Status Update:** After re-submitting, the status will change back to "**Pending document check**" for further review.
- **Processing Time:** It typically takes approximately 2-5 working days to process the visa application.

Step 6

e-Visa Confirmation Sent by Email

- **Approval:** Once approved, the status will change to "**Finished**", and an **e-Visa Confirmation** document will be sent to your registered email.
- **Manual Download:** You can also download the confirmation document directly from the "**Download**" menu on the e-Visa website.
- **Travel Requirement:** You **must print the e-Visa confirmation document** to present to the airline and immigration officers upon arrival in Thailand.

FAQ / Q&A Section



Q : Where do I apply for the visa?

A : All applications must be submitted through the Thai e-Visa system at www.thaievisa.go.th.

Q : Do Ordinary Passport holders eligible for a Courtesy Visa have a stay limit?

A : Yes. Please note that Courtesy Visas for Ordinary Passport holders are strictly for stays of up to 90 days only.

Q : If I am a participant holding a Registration Confirmation Letter (such as a member of the media or a guest) with an ordinary passport, which type of visa do I need to apply for?

A : Any badged participant holding an ordinary passport, including members of the media and invited guests, who has received a Registration Confirmation Letter falls under [Type 2](#).

Q : If I am a Participant holding a diplomatic or official passport, which type of visa do I need to apply for?

A : - If you are from a country with a bilateral visa exemption agreement with Thailand, you fall under [Type 3](#).
- If you are from a country without a bilateral visa exemption agreement with Thailand, you fall under [Type 4](#).

Q : Who is considered to be invited by Thai government agencies to participate in the 2026 Annual Meetings?

A : Participants who have registered for the 2026 Annual Meetings and received a registration confirmation.
